

VISUAL DATA INTEGRATOR

The Data Integrator is a robust Extraction, Transformation, and Loading (ETL) tool that contains a large suite of powerful data manipulation functions including joins, table lookups, and filters. The Visual Data Integrator is a good starting point for new users who prefer to define data integration work flows using graphical objects, letting the application create the underlying script syntax.

BUILDER

VISUAL BUILDER

Builder transforms data by summarizing, indexing, and preprocessing it in order to create the data Models. Automatic Model builds can be set up using DI-Scheduler. The Visual Builder is a rapid prototyping tool that provides most of the functionality of Builder using dialogs that help guide the user through the Model build process.

DOMAIN EDITOR

Domain Editor is an application designed to make the initial phases of development easier by simplifying the data relationship discovery phase of The Diver Solution. Domain Editor uses the standard Dimensional Insight data directory structure to place integrator programs and builder description files in a Project container called a Domain. It facilitates the creation of programs used for extraction and joining, and description files.


